#### Purpose

This role provides the opportunity to use and enhance your excellent retail skills whilst making a direct impact to help the lost and abandoned animals in SA

The purpose of this volunteer role is to support the Retail Coordinator and Thrift Shop Team Leader in the day to day duties of an AWL Thrift Shop. With every purchase from an AWL Thrift Shop supporting programs that help the animals in our care and educating our community about animal welfare.

#### Volunteer duties and responsibilities

#### Duties

- Applying visual merchandising recommendations from Thrift Shop Team Leader and Retail Coordinator to use space productively to maximise sales
- Maintain your shift in accordance with the roster for volunteers of this AWL Thrift Shop
- Ensure outgoing donations are ready for collection by van drivers
- Ensuring products are priced and displayed in accordance with AWL Thrift Shop procedures
- Helping the Store Team Leader to constant visual appeal of our stock
- Assisting with stock management and general storekeeping duties
- Assessing and sorting incoming donations for suitability of sale
- Pricing Incoming stock ready for display
- Accurate cash handling and use of Point of Sale equipment
- Taking a proactive approach to WH&S in accordance with store policies and procedures
- Providing excellent customer service to clients and customers

#### Work Health and Safety
