## Job Specification

**ROLE:** Thrift Shop Driver

**REPORTS TO:** Retail Coordinator

**LOCATION:** AWL Shops, Gillman Sorting Centre and multiple public locations

**SHIFT TIMES:** 9am – 4:00pm at least 1 day/week

## Purpose

This role provides the opportunity to use and enhance your excellent driving and customer service skills whilst making a direct impact to help the lost and abandoned animals in SA

The purpose of this volunteer role is to support the Retail Coordinator and Store Teams in the day to day duties of an AWL Thrift Shop. With every purchase from an AWL Thrift Shop supporting programs that help the animals in our care and educating our community about animal welfare.

## Volunteer duties and responsibilities

- Service the AWL shops utilising an AWL vehicle
- Deliver donations from the Sorting Centre to the AWL Thrift shops.
- Collect excess/unwanted donations from the AWL Thrift shops and deliver to the Sorting Centre.
- Collect donations, including furniture, from other locations as requested by Retail Co-Ordinator.
- Helping the Retail Co-Ordinator and Store Teams to maintain consistent visual appeal of our stock
- Assisting with stock management and general housekeeping duties at Sorting Centre
- Taking a proactive approach to WH&S in accordance with AWL policies and procedures
- Providing excellent customer service to clients and customers
- Maintain fuel level, cleanliness and appearance of AWL vehicles
- Assess incoming donations to determine quality and suitability for sorting and sale or usage by AWL.
- Deliver pre purchased furniture from AWL Thrift shops to customer locations
- Maintain appropriate standards of grooming and presentation
- Any other tasks as allocated by Retail Co-Ordinator

## Work Health and Safety
